
- FIRST:** The date of filing of the Articles of Incorporation (the "Articles") of the Corporation with the Florida Department of State was December 14, 2007 at 4:25 p.m. and assigned document number P07000132136.
- SECOND:** The Articles are hereby amended by deleting the last sentence of Article I, Section 1.3.
- THIRD** The Articles are hereby amended by deleting Article II of the Articles in its entirety and, in its place, inserting the following:  
  
"ARTICLE II – Intentionally omitted.
- FOURTH:** The Articles are hereby amended by deleting "/Subordination" in the title of Article III to now read "Board of Directors".
- FIFTH:** The Articles are hereby amended by deleting Article III, Section 3.2 entitled *Subordination* in its entirety, and in its place, inserting the following:  
  
Section 3.2 – Intentionally omitted.
- SIXTH:** The Articles are hereby amended by deleting Article IV of the Articles in its entirety and, in its place, inserting the following:  
  
"ARTICLE IV – Intentionally omitted.
- SEVENTH:** In the event of a conflict between the terms of this instrument and the terms of the Articles, the terms of this instrument shall prevail and control. Except as the Articles may be modified by this instrument, the Articles are ratified and confirmed in all respects.
- EIGHTH:** These Articles of Amendment were approved by Written Consent of the Shareholders and the Board of Directors of the Corporation on the 4th day of October, 2016.
