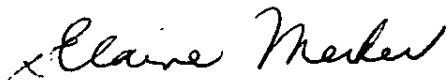

ARTICLES OF INCORPORATION

OF

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **JAYDAN FINANCIAL SERVICES, INC.**

The period of its duration is perpetual.

ARTICLE EIGHT

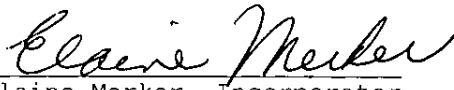
The Board of Directors is empowered to make, alter or repeal the Bylaws
