ARTICLES OF INCORPORATION  
OF

THE UNDERSIGNED, acting as sole incorporator under Chapter 607 of the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for TURBINE INTEGRATED TECHNOLOGY SERVICES CORP., a Florida corporation (the "Corporation");

ARTICLE I  
NAME

SHARES


