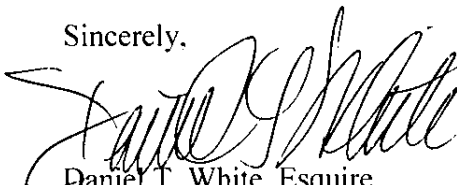

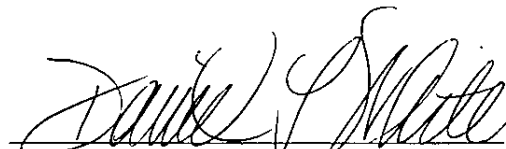

The date on which the filing of these Articles of Incorporation shall become effective, and the date on which the legal existence of this Corporation shall commence, shall be January 1, 2008.

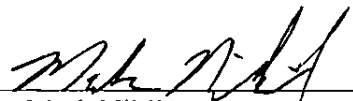
