ARTICLES OF INCORPORATION
OF

Virga's Curb Appeal, Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Virga's Curb Appeal, Inc.

ARTICLE II

The existence of the Corporation shall begin on December 19, 2007.

ARTICLE III

The street address of the principal office of the Corporation is 222 Scooter Drive, Panama City Beach, Florida 32408.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100 par value \$.01 per share, all of which shall be Common Shares. 

The corporation is formed with the express purpose of conducting any and all business allowed under Florida law.


