### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of **EAGLES CHRISTIAN ACADEMY**, **INC.**, under the Florida General Corporation Act, adopts the following Articles of Incorporation.

### ARTICLE I. NAME

The name of the corporation is:
