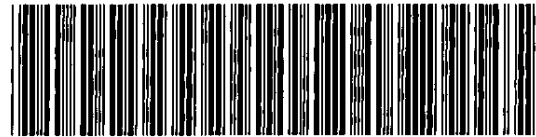



ARTICLE I
