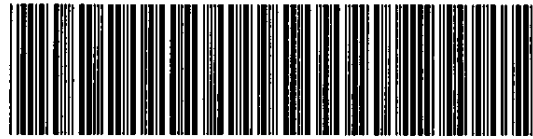

ARTICLE I – NAME AND ADDRESS
