## ARTICLES OF MERGER OF

EXPERTYPE, INC. (a New York Corporation)

INTO

EXPERTYPE, INC. (a Florida Corporation)

Under Section 75 of the Florida General Corporation Act

Pursuant to the provisions of Section 75 of the Florida General Corporation Act, the undersigned hereby certify:

FIRST: The following Plan of Merger has been duly approved by the Board of Directors of each of the constituent corporations:

- (a) The name of each of the constituent corporation is EXPERTYPE, INC., a New York corporation and the name of the surviving corporation is EXPERTYPE, INC., a Florida corporation.
- (b) The terms and conditions of the proposed merger and the manner and basis of converting the shares of each constituent corporation are as follows:

The shareholders of EXPERTYPE, INC., a New York corporation shall receive one share of EXPERTYPE, INC., a Florida corporation in exchange for each share they hold of EXPERTYPE, INC., a New York corporation.

SECOND: The date of adoption of the Plan of Merger by the shareholders was December 17, 2007. The Plan of Merger was adopted by the unanimous vote of shareholders of EXPERTYPE, INC., a New York corporation and EXPERTYPE, INC., a Florida corporation at a meeting called for that purpose.

THIRD: The surviving corporation agrees that it will promptly pay to the dissenting shareholders of each constituent domestic corporation the amount, if any, to which they shall be entitled under the provisions of the General Corporation Act relating to the rights of dissenting shareholders.
