**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**CAPITAL STOCK**


**ARTICLE VII**


