The undersigned subscriber to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - CORPORATE NAME

This corporation shall exist perpetually unless dissolved according to Florida law.

ARTICLE IX - BYLAWS



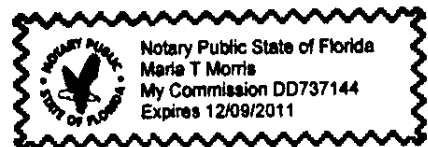


