

# ARTICLES OF INCORPORATION OF JL & WL CORPORATION

#### **ARTICLE I- NAME**

The name of this Corporation is JL & WL Corporation. The mailing address is: 3089 Carysfort Lane, Margate, FL 33063

#### **ARTICLE II- DURATION**

The Corporation shall have a perpetual existence. The Corporation shall commence existence on the date of the filling of this Articles of Incorporation by the office of the Secretary of State of Florida.

### **ARTICLES III- PURPOSE**
