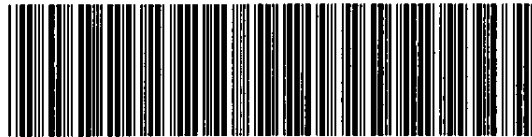

**ARTICLE I
CORPORATE NAME**

The name of this corporation is RUSS TOTAL LAWN MAINTENANCE INC., and its principal place of business shall be located at 311 West 37th Street, Riviera Beach, FL 33404.

**ARTICLE II
CORPORATE NATURE**

This is a corporation that shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.


