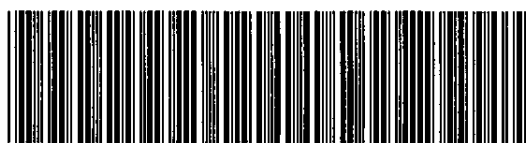



In compliance with the requirements of F. S. Chapter 607, the undersigned hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Quality Printing & Publishing, Inc..

ARTICLE II

The existence of the Corporation shall begin on: January 1, 2008

ARTICLE III

The street address of the principal office of the Corporation is: 902 N Sinclair Avenue, Tavares, Fl. 32778

ARTICLE IV




