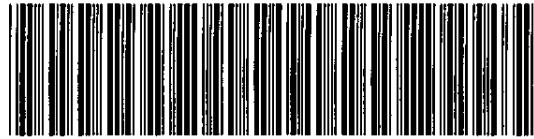

ARTICLE I, NAME OF CORPORATION:

ARTICLE II, GENERAL NATURE OF BUSINESS:

The general nature of the business and the object and purpose to be Transacted and carried on are,

To conduct all business not prohibited by the laws of the United States and Stated Of Florida.
