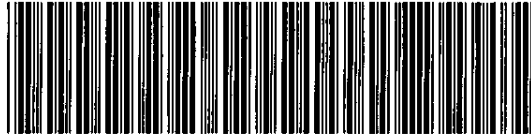



OF

In compliance with Chapter 607, F.S., Florida Profit

ARTICLE ONE

The name of the corporation is **TOWER PARK MANAGEMENT, INC.**

The period of its duration is perpetual.


ARTICLE EIGHT
