**STATEMENT OF

This Statement of Fact, dated January 26, 2021, is filed with the Florida Department of State, Division of Corporations (the "**Division**") to correct the corporate records of Holding BRI 1814 GGOP, Inc., a Florida corporation (the "**Corporation**"), Document Number P08000001021. We request that this Statement of Fact be added to the corporate records of the Corporation as a matter of public notice.

On July 17, 2020, an identity thief submitted a fraudulent, unauthorized filing with the Division (the "**First Fraudulent Filing**") that reinstated the active status of the Corporation as a Florida corporation and changed the: (a) mailing address; (b) name of the registered agent; and (c) officer/director detail of the Corporation. The First Fraudulent Filing included identifying **Lakie Slobodan** ("**Mr. Slobodan**") as an officer, director and the registered agent of the Corporation. The identity thief signed the First Fraudulent Filing as **Mr. Slobodan**. However, neither Claudio Dombey, Ariel Bentata, Moises Benzaquen or Daniel Goldstein made or authorized this filing with the Division.

Further, on July 19, 2020, the identity thief submitted a fraudulent, unauthorized Amended Annual Report with the Division (the "**Second Fraudulent Filing**") that changed the: (a) name of the registered agent; and (b) officer/director name of the Corporation. The Second Fraudulent Filing included identifying **Milan Zurkovic** ("**Mr. Zurkovic**") as an officer, director and the registered agent of the Corporation. The identity thief signed the Second Fraudulent Filing as **Mr. Zurkovic**. However, Claudio Dombey, Ariel Bentata, Moises Benzaquen or Daniel Goldstein did not make or authorize this filing with the Division.

Further, on July 21, 2020, the identity thief submitted a fraudulent, unauthorized Amended Annual Report with the Division (the "**Third Fraudulent Filing**") that changed the: (a) name of the registered agent; and (b) officer/director name of the Corporation. The Third Fraudulent Filing included identifying **Mr. Zurkovic** as an officer, director and **Mr. Slobodan** as an officer, director and as the registered agent of the Corporation. The identity thief signed the Third Fraudulent Filing as **Mr. Slobodan**. However, Claudio Dombey, Ariel Bentata, Moises Benzaquen or Daniel Goldstein did not make or authorize this filing with the Division.


On information and belief, (1) in June 27, 2017, the legal owners of the Corporation sold the assets of the Corporation and the Corporation no longer operates; and (2) 2017 was the last year that the legal owners of the Corporation renewed the Corporation with the Division.

For the avoidance of doubt, there is no, and has never been any, affiliation between the Corporation and **Mr. Zurkovic** or **Mr. Slobodan**, and neither **Mr. Zurkovic** or **Mr. Slobodan** has ever served as a registered agent, director, officer or shareholder of the Corporation.
