The undersigned persons hereby associate for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Florida Statute §607.0202.

**Article I**

The name of the corporation shall be **JASON FOX ENTERPRISES, INC.**

**Article II**

The mailing address of the principal office of the corporation shall be:

120 S. Willow Avenue  
Tampa, Florida 33606

**Article III**

The purpose for which the corporation is being formed and the general nature of the corporation's business shall be real estate investment services, as well as to engage in any other activity or business permitted under the laws of the State of Florida.

**Article IV**

The amount of capital stock of the corporation shall be One Thousand (1,000) shares of common stock with a par value of \$.01 per share.

**Articles V**

The amount of capital with which the corporation will begin business will be no less than Five Hundred Dollars (\$500.00).

**Article VI**

The entire voting power for the selection of directors and for all other purposes shall be






