In conjunction with domesticating Prima Investments, Inc., a Nevada corporation, in Florida, we filed domestication documents to create a Florida corporation of the same name; we received the attached rejection letter informing us that the name is not distinguishable from the name of an existing Florida entity, a copy of which is attached hereto. We subsequently requested the name and our request was again denied.

ARTICLES OF INCORPORATION

The undersigned, desiring to convert a foreign corporation to a Florida corporation for profit (the "Corporation") under the laws of the State of Florida, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the Corporation is Prima Investments, Inc.

ARTICLE II PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office and mailing address of the Corporation is located at 6717 NW 48th Lane, Gainesville, Florida 32553.

ARTICLE III CAPITAL STOCK

- (a) Authorized Shares. The total number of shares of stock that the Corporation may issue is 1,000 shares of common stock having a par value of \$0.10 per share. Each of the voting shares shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. All or any part of the stock may be paid for in cash or in property at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock, when issued, shall be fully paid and nonassessable.
- (b) <u>Capital Stock</u>. The capital of the Corporation shall be at least equal to the sum of the aggregate par value of all issued shares having par value plus such amounts as, from time to time, by resolution of the Board of Directors, may be transferred thereto.
- (c) <u>Corporate Liquidation and Dissolution</u>. In the event of voluntary or involuntary liquidation, dissolution or winding up of the Corporation, the holders of record of the common stock shall be entitled to receive distribution, ratably, of the remaining assets of the Corporation.
 - (d) <u>Preemptive Rights</u>. The Corporation elects not to have preemptive rights.
 - (e) <u>Cumulative Voting</u>. Cumulative voting shall not be permitted.
