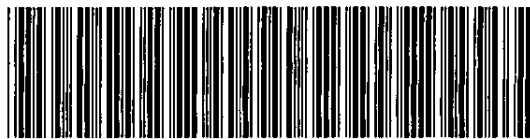



ARTICLES OF INCORPORATION OF

G & G TRANSPORTATION SERVICES INC.

ARTICLE I

Name of Corporation

The name of this corporation is G & G TRANSPORTATION SERVICES INC.

ARTICLE II

Purpose

Organized primarily as a transportation service company, G & G TRANSPORTATION SERVICES INC. will, with the approval of its Board, transact any and all other lawful businesses permitted under the laws of the United States and the State of Florida.

ARTICLE III

Capital Stock

Initially, this Corporation is authorized to issue 10,000 shares of common stock at \$0.01 dollar par value.

ARTICLE IV

Corporate existence

This corporation shall exist for a perpetual period of time and shall be **effective January 2, 2008**. It shall have offices throughout and outside the State of Florida.

ARTICLE V

Capital Stock Voting Rights

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of outstanding common shares.

ARTICLE VI

Principal Place of Business

The initial place of business is 1143 SW Hogan Street, Port St-Lucie, FL 34983. The mailing address is the same as the place of business. The Board of Directors may from time to time move the principal office to any other address in Florida and establish branch offices at any other place within or without the State of Florida.






