

Articles of Incorporation Of Zero Points Traffic School, Inc.

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I Name

The name of the corporation shall be: Zero Points Traffic School, Inc.

Article II Nature of Business

The corporation shall have the powers to engage in any lawful activity for which corporations may be organized under the Florida Business Corporation Act.

Article III Mailing Address

The initial mailing and principal address of the corporation is:

Article IV Duration

Article V Capital stock

The directors shall be protected from personal liability to the fullest extent permitted by the Florida Business Corporation Act.
