ARTICLES OF INCORPORATION

OF

The undersigned, acting as the incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts these Articles of Incorporation for such Corporation.

ARTICLE I - NAME OF CORPORATION

The name of this Corporation will be **Florida Lift and Care, Inc.**

ARTICLE II - TERM OF EXISTENCE

This Corporation will commence its existence upon the filing of these Articles and will exist perpetually unless dissolved according to law.

ARTICLE IV - GENERAL PURPOSE




ARTICLE IX - INDEMNIFICATION
