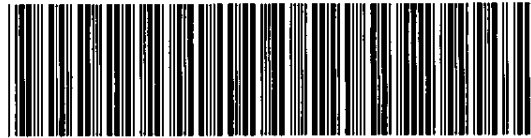

TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of section 607.1006, Florida Statutes, this corporation adopts the following Articles of Amendments to its Articles of Incorporation:

FIRST: Article 7 of the Articles of Incorporation of THE GREAT HOUSE PUBLISHING INC. states:

The maximum number of shares that this Corporation is authorized to have outstanding at any time is **TEN THOUSAND (10,000)** shares of common stock, each having the par value of **ONE CENT (\$.01)**.

SECOND: The corporate capitalization of THE GREAT HOUSE PUBLISHING INC. will be amended to state:

The maximum number of shares that this Corporation is authorized to have outstanding at any time is **SEVEN HUNDRED BILLION (700,000,000,000)** shares of common stock, each having the par value of **ONE DOLLAR (\$1.00)**.
