I, the undersigned do hereby form a corporation for the purpose hereinafter stated and do hereby certify as follows:

ARTICLE I - NAME

The name of the corporation shall be and is hereby declared to be CLEAR SPEECH, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business is 12486 Autumnbrook Trail E, Jacksonville, Florida 32258.

ARTICLE III - PURPOSE
