**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF**

**AMERICAN IN-HOME CAREGIVER REGISTRY, INC.**

The undersigned, the Chief Executive Officer of AMERICAN IN-HOME CAREGIVER REGISTRY, INC., a Florida corporation (the "Corporation"), desiring to amend the Articles of Incorporation of the Corporation pursuant to Section 607.1006 of the Florida Business Corporation Act, states as follows:
