- 2. The number of shares the corporation is authorized to issue shall be 500 shares all of one class designated as common stock, at \$1.00 per value.**
- 3. The street address and county of the initial principal office of the corporation is: 15780 SW 84 Terrace Miami, Fl. 33193, Miami-Dade County and the name of the initial register agent at this address is: Maria L. Moll at the same address.**


