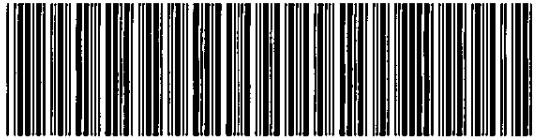

The undersigned incorporator is forming a for-profit corporation in accordance with Chapter 607 of the Florida Statutes and adopts the following articles of corporation.

**ARTICLE I
(NAME)**

The name of the corporation is **MASON BILLINGSLEA ENTERPRISES, INC.**

**ARTICLE II
(PRINCIPAL OFFICE)**

The address of the corporation's principal office is 3352 Wax Berry Court, Windermere, Florida 34786.

**ARTICLE III
(PURPOSE)**

This corporation is organized for the following purposes:

A. To own property, enter contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

B.
