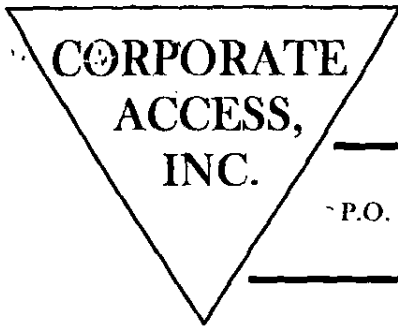



ARTICLE X – GENERAL


- A.) Unless otherwise stated in the By-laws, every stockholder who has the right to vote, and shall have the right to vote in person or by proxy.
