ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of this Corporation pursuant to

Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the

State of Florida and adopts these Articles of Incorporation for such Corporation.

ARTICLE I - NAME OF CORPORATION

The name of this Corporation will be Shua, Inc.

ARTICLE II - TERM OF EXISTENCE

This Corporation will commence its existence on the date of filing of these Articles and will exist perpetually unless dissolved according to law.

ARTICLE IV - GENERAL PURPOSE
