The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1.0 NAME AND ADDRESS

The name of the Corporation is West King Street Properties, Inc. The location of the principal place of business and mailing address is 222 West King Street, St. Augustine, Florida 32084.

ARTICLE 2.0 DURATION

The duration of the Corporation is perpetual.
