Pursuant to the provisions of Sections 607.1006 and 607.1007, Florida Statutes, this *Florida Profit Corporation* adopts the following amended and restated Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is Robert J. Paresi Jr., MD, P.A. (the "Corporation").

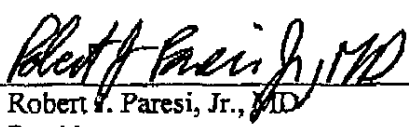
