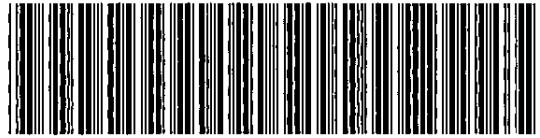

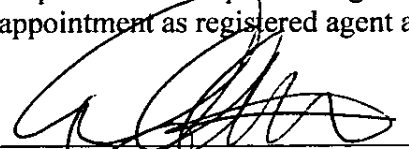
The effective date of this corporation is January 11, 2008. This corporation shall exist perpetually.
