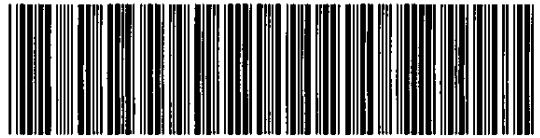




1. The name of the corporation is Pryor & Associates, Inc.


