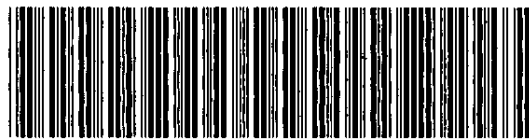



2) Other than hereinabove set forth, said Articles of Incorporation as originally adopted, shall remain in full force and effect.


