ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE FAKS.COM, INC.

Pursuant to Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, the undersigned, being the Incorporator of THE FAKS.COM, INC., a Florida corporation (the "Corporation"), bearing Document Number P08000007861, does hereby submit these Articles of Amendment for the purpose of amending the Corporation's Articles of Incorporation as follows:

FIRST: Article V of the Corporation's Articles of Incorporation shall be deleted in its entirety and replaced with the following:

"ARTICLE V CAPITAL STOCK

The maximum number of shares that the Corporation shall be authorized to issue and have outstanding at any one time shall be Twenty-One Million (21,000,000) shares, of which:

- (i) Twenty Million (20,000,000) shares shall be designated Common Stock, \$0.0001 par value. Each issued and outstanding share of Common Stock shall be entitled to one (1) vote on each matter submitted to vote at a meeting of the shareholders;

The Board of Directors of the Corporation, by resolution or resolutions, at any time and from time to time, shall be authorized to divide and establish any or all of the unissued shares of Preferred Stock into one or more series and, without limiting the generality of the foregoing, to fix and determine the designation of each such share, the number of shares which shall constitute such series and certain preferences, limitations and relative rights of the shares of each series so established."

SECOND: The Company has not yet issued shares and this amendment was adopted by the Incorporator on February 12, 2008, in accordance with the provisions of Section 607,1005 of the Florida Business Corporation Act.
