**ARTICLE I - NAME OF CORPORATION**

The name of the corporation is **BRUNSWICK FOOD SERVICE EDUCATORS, INC.**

**ARTICLE II - NATURE OF BUSINESS**

The initial address of the principal office of the corporation is to be at 7002 Brunswick Circle, Boynton Beach, Florida 33472.






