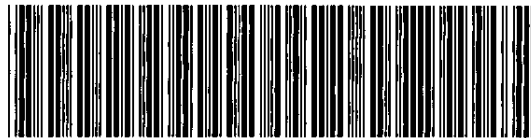

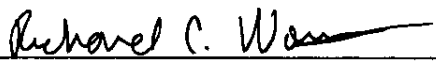
ARTICLE VII
