The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the folkswing Articles of Incorporation:

## ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is <u>4 KIDS ONLY TRANSPORTATION</u>, INC., hereinafter referred to as the "Corporation".

# ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

## ARTICLE III: DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.
