Pursuant to the provisions of section 607.1006, Florida Statutes, the undersigned  
Florida corporation adopts the following amendments to its Articles of Incorporation:


1. Article I of the Articles of Incorporation of Real Peak Management, Inc. is hereby  
amended in its entirety to read as follows:

**"ARTICLE I**  
**Name and Duration**

The name of the Corporation is Real REO Solutions, Inc. The duration of the
