The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

#### **ARTICLE I**

#### <u>Name</u>

The name of the corporation is B & B of Volusia County, Inc..

#### **ARTICLE II**

## **Principal Office**

The principal office and mailing address of the corporation shall be 753 Marina Point Drive, Daytona Beach, Florida 32114.

#### ARTICLE III

#### **Duration**

This corporation shall exist perpetually.
