ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is Florida Jet Parts, Inc.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing upon filing of these Articles.

ARTICLE III - BUSINESS AND PURPOSE

This Corporation is organized for the following purposes:

To have and to exercise all the powers now or hereafter conferred by the laws of the State of Florida upon corporations organized gursuant to the laws under which this Corporation is organized and any and all acts amendatory thereof and supplemental thereto.
