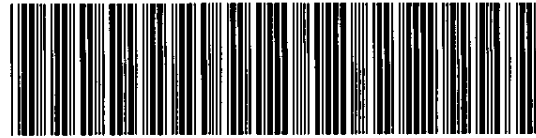

ARTICLE I - NAME

The name of this corporation is Florida Gulf Coast Realty & Assoc., Inc.

ARTICLE II - PRINCIPAL OFFICE
