ARTICLES OF INCORPORATION OF

I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

ARTICLE I

This corporation may engage in any activity or business permitted under the Laws of the State of Florida.

ARTICLE IV

This corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpertually thereafter unless sooner dissolved according to law.

ARTICLE V
