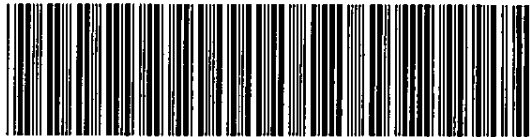

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000.00) of no par value.

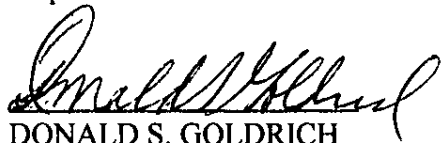
ARTICLE FIVE

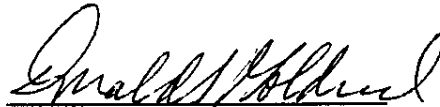
The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
