ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of the captioned professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this professional corporation is John Dingfelder, P.A., and its principal office and mailing address is 3006 San Carlos Street, Tampa, FL 33629.

ARTICLE II

Commencement of Corporate Existence

The professional corporation shall come into existence on the date of filing with the Florida Secretary of State.

ARTICLE III

General Nature of Business

The professional corporation has been formed for the purpose of engaging in the practice of law through its officers, employees and agents who are licensed to practice law in the State of Florida, and any business incidental thereto which is lawful under the Florida Professional Service Corporation and Limited Liability Company Act.

Capital Stock

The aggregate number of shares of stock authorized to be issued by this professional corporation shall be 1000 shares of common stock, each with a par value of \$.001. By-Laws


