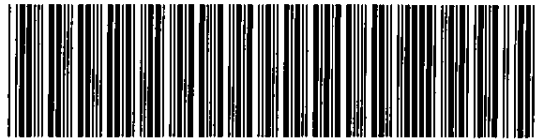

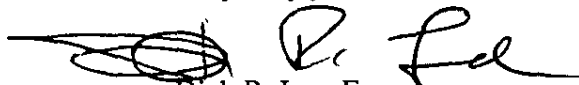

OF

ARTICLE I- NAME

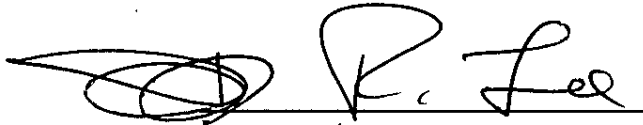
