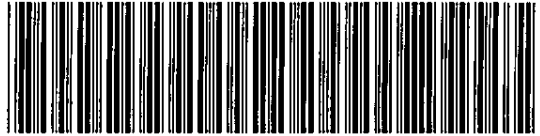

NAME

The name of this corporation is STRAKER HOLDINGS, INC

ARTICLE II

DURATION

This corporation shall have perpetual existence.
