

ARTICLES OF INCORPORATION OF JP & D GROUP, INC.

The undersigned incorporator, a natural person competent to contract, hereby forms a SECRETARY OF STATE under the laws of the State of Florida.

ARTICLE I - NAME

The name and address of this corporation shall be:

ARTICLE II - EXISTENCE
