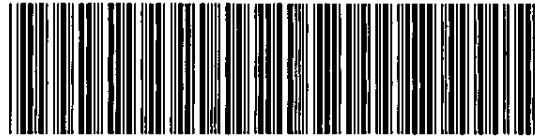




Article – Fourteen
