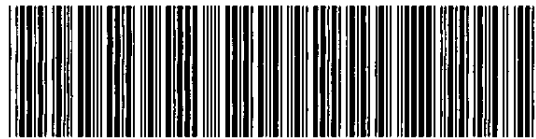





FIRST: Amendment adopted


